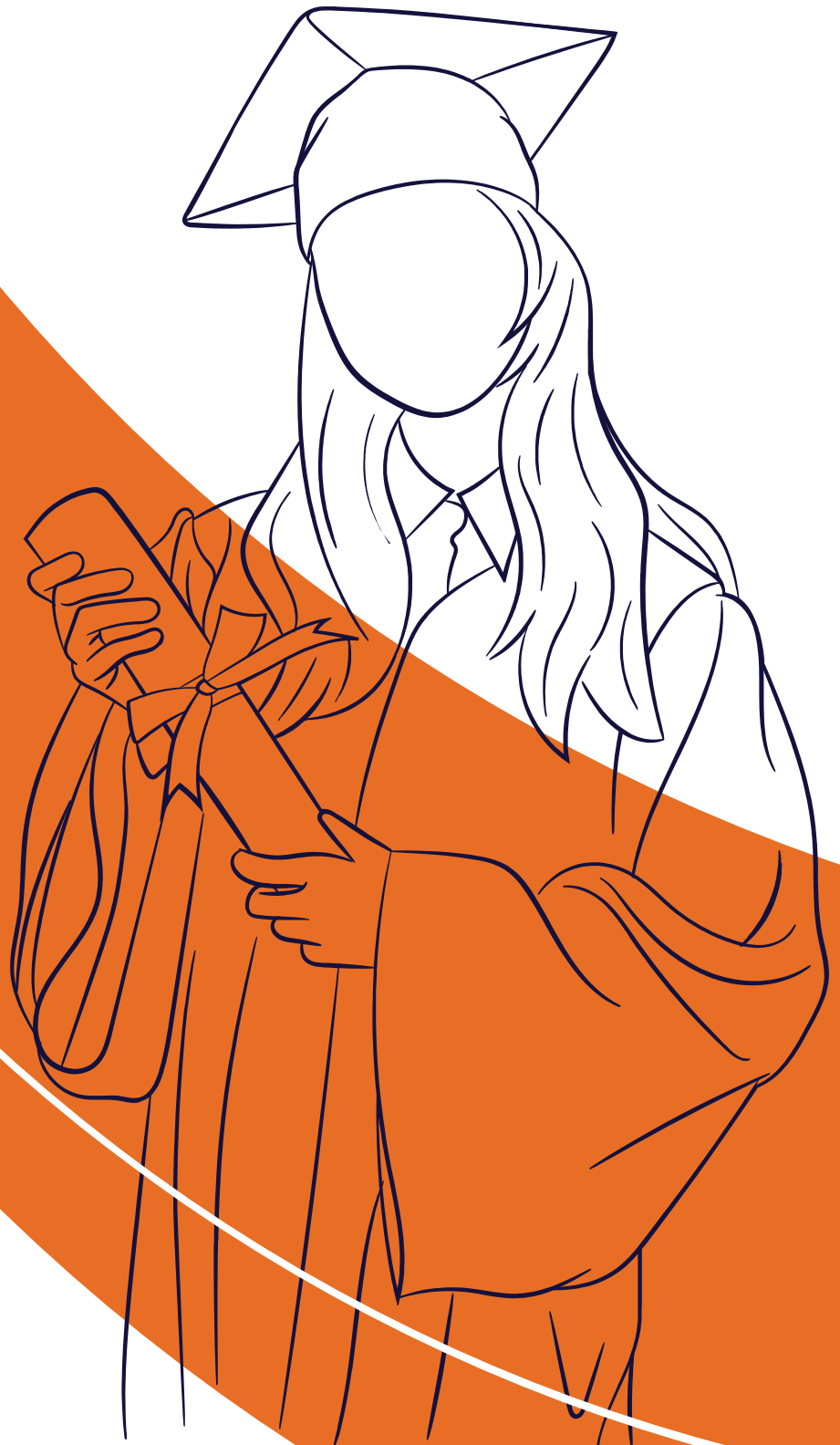

# Scholarships

---

We know that many students aspire to go to uni to gain a degree or go to TAFE and study towards a diploma, but for many students the costs make this unattainable. Higher education isn't free, it costs \$20,000–\$45,000 to complete a Bachelor degree and, if you have to live on campus, the fees are on average \$20,000 a year. And that's before you buy any textbooks, study materials, or IT equipment!

Scholarships exist to increase opportunities for someone just like you to access higher education. Being awarded a scholarship could mean the difference between accepting or turning down a place at university.

There are scholarships specifically tailored to the needs of regional students, and even though you might not think you are eligible, no matter what your situation or background, there is a scholarship that you can apply for.

Examples of types of scholarships include:

- Access for regional and rural students
- Residential scholarships
- Travel and study grants
- Placement grants
- Areas of study, such as agriculture, the health professions and teaching
- Scholarships for people from diverse backgrounds.

In case you are thinking you won't have a chance, let's address some common myths about scholarship success. Many people think that to get a scholarship:

- You need to be academic.
- The odds are against you because so many apply, and you don't have a hope.
- You have to be good at writing essays.

None of these are true. It is true that you will not get a scholarship unless you apply for one!

It is also true that your chances of success depend on finding the right scholarship to suit your circumstances and needs.

There are a number of key steps to follow to enhance your chances of success:

1. Commit: Decide that you want to apply for a scholarship
2. Assess: Find scholarships that you are eligible for
3. Research: Look far and wide
4. Knowledge: Know your audience/know what they are looking for
5. Awareness: Pay attention to your competition
6. Quality: Proofread everything!
7. Determination: Perseverance furthers! If at first you don't succeed – apply again, and again...

## Timing: when do you apply?

It is important to take note of the opening and closing dates for the scholarship you are applying for – different scholarships will have different timelines to adhere to. Make sure you allow plenty of time to prepare your application and to collect any additional information or documents that may be required.

## VTAC Scholarship Applications: What are they?

Many Victorian universities use the VTAC platform to process scholarship applications, particularly for students applying to study for the first time. There are various types of scholarships you can apply for through VTAC, including:

- Financial disadvantage
- Academic Achievement
- Being the first in your immediate family to attend university
- Being an Indigenous Australian
- Being a refugee or asylum seeker
- Having to relocate to attend tertiary study
- Intending to live on campus
- Having been in formal out-of-home care
- Having a disability or medical condition that affects your education
- Having experienced difficult circumstances that have affected your education
- Community service
- Leadership
- Being a student from Gippsland committed to regional and rural health and applying to Monash.

## How to apply via VTAC:

1. Applications for 2024 are open 29th July and close at 5pm on 11th October. You'll need to complete your application and provide all additional information and documentation by that deadline.
2. Go to the VTAC website – [www.vtac.edu.au](http://www.vtac.edu.au)
3. Create an account with VTAC or log in to the one you have already created using your VTAC ID & PIN.
4. Select 'Scholarship Application' in your VTAC user account (all applications are submitted online)
5. Enter all your personal details & provide additional information if required

Not all institutions use the VTAC platform to process scholarship applications. Below is a table showing the institutions that use VTAC and the eligibility requirements. For other institutions, refer to the relevant links at the end of this guide.

<b>Charles Sturt University</b>	Accepts Australian citizens and holders of an Australian permanent residency visa and will not accept New Zealand citizens and holders of an Australian temporary/student residency visa.
<b>Deakin University</b>	Accepts Australian citizens, New Zealand citizens and holders of an Australian permanent residency or humanitarian visa. Will not accept holders of an Australian temporary/student residency visa.
<b>La Trobe University</b>	Accepts Australian citizens, New Zealand citizens and holders of an Australian permanent residency visa. Will not accept holders of an Australian temporary/student residency visa.
<b>RMIT University</b>	Accepts Australian citizens, New Zealand citizens and holders of an Australian permanent residency visa. Will not accept holders of an Australian temporary/student residency visa.
<b>Swinburne University of Technology</b>	Accepts Australian citizens and holders of an Australian permanent residency visa or humanitarian visa. Will not accept New Zealand citizens and holders of an Australian temporary/student residency visa.
<b>Victoria University</b>	Accepts Australian citizens, New Zealand citizens and holders of an Australian permanent residency visa or humanitarian visa or temporary visa. Will not accept holders of an Australian student residency visa.

# Local Scholarships

## Freemasons Foundation Victoria (FFV) – Tertiary Support

Scholarships of up to \$3,000 are available to provide assistance to tertiary students attending their first tertiary course at University or TAFE in Victoria who require financial support with their studies.

General guidelines of eligibility for a Tertiary Support Scholarship are as follows:

- An Australian Citizen or Permanent Resident of Australia domiciled in Victoria;
- Low socio-economic status background; or
- Demonstrated financial need. Students must be able to demonstrate financial need and be able to provide supporting documentation and evidence at the time of application. For example, Commonwealth income support payments such as Youth Allowance, Austudy, or the necessity to relocate to undertake their chosen course of study.
- Satisfactory academic merit.

There are currently 2 rounds available each year, closing on 31 March and 31 August each year.

## Swan Hill Rural City Council – Youth Endeavour Scholarship

Council has established a scholarship program, coordinated by secondary schools within the municipality, to support school leavers wanting to undertake further education or training to assist with career opportunities or take on a new job.

Eligibility:

- have shown commitment to study and have the aspirations to complete further training, study or pursue career opportunities after secondary school (eg. Tafe, University, Apprenticeship etc)
- or who may require financial assistance to take the next steps after secondary school

The scholarship may be used for, but not limited to, the following items:

- education and training fees, books or uniform
- purchase of a vehicle, driving lessons, licence fees
- tools and equipment

Schools are responsible for student nominations and the coordination of scholarship timelines.

## **Youthrive Victoria – Rural Chances Vocational Scholarships**

Scholarships are available for young rural Victorians looking for work or opportunities to train further and build their skills. There are larger scholarships valued at \$5000 assist young people to move away from their home town or to assist with extensive travel required to complete training qualifications, along with mentoring and leadership and networking opportunities. As well as smaller scholarships of up to \$2000 for specific items to support training such as for equipment, course fees, tools of trade, travel costs, materials etc., along with the offer of mentoring and leadership and networking opportunities.

### Eligibility:

- Be 16–24 years of age;
- Hold a current Centrelink health care card, or can provide evidence of significant financial hardship;
- Identify a TAFE qualification (Certificate III or above) they would like to enrol in or are enrolled in OR an apprenticeship they would like to undertake;
- Be willing to be accountable for the use of scholarship funds;
- Be willing to participate in publicity/promotional material and research.

### Key Dates for Rural Chances Scholarships

- 2025 Applications open: 17th June, 2024
- 2025 Applications close: 4th November 2024 (Midnight)
- 2025 Application assessment period: Early/Mid November 2024
- 2025 Scholarship interviews: Mid/Late December 2024
- 2025 Scholarship notification of outcome: December 2024

## **Mallee Family Care (MFC) – Chances for Children Tertiary Scholarship**

The Chances for Children Tertiary Scholarship supports young people aged 24 and under to undertake university, TAFE or apprenticeship studies locally or outside the Mallee region. It can help cover some of the costs associated with course fees, textbooks, living away from home and other expenses.

### Eligibility:

- an Australian citizen living in northwest Victoria or southwest New South Wales
- a young person 24 years old or under
- financial reasons for needing help to support your education.

### Application Dates\*:

- Monday 26th August 2024 – Monday 28th October 2024
- Monday 25th November – Tuesday 14th January 2025

\*For funding in the 2025 academic year



## **Sunraysia Institute of TAFE and Chances for Children Scholarship**

This scholarship will provide \$5000 per year to support students experiencing financial hardship whilst studying a course at SuniTAFE.

### **Eligibility:**

- are Australian citizens
- are aged between 16 and 25
- reside in north-west Victoria or south-west New South Wales
- are able to demonstrate financial hardship
- will be studying at one of the Sunraysia Institute of TAFE campuses

Applications to Chances can be accepted at any time throughout the year. Applications are assessed twice a year in October and January.

## **Dr Allan Antcliff AM Memorial Scholarship**

This award has been dedicated to the memory of Dr Allan Antcliff, AM. The scholarship is awarded to a student undergoing training in Production Horticulture, who has achieved a level of excellence in the first stage or year of a course, and is going on to complete a second stage, or year, of a course. The awardee would thus be selected at the conclusion of the first stage, or year. The scholarship is for \$1,000 (including GST).

The scholarship is intended to assist the student in meeting the costs of course fees, text books, and other requisites in the second year of the course.

### **Eligibility:**

- The top student in the first year of the 2 year Diploma of Production Horticulture course
- In the event there are no students in the above course, then the scholarship is to be divided equally between:
  - The top first year fruit growing apprentice, going into second year
  - The top second year fruit growing apprentice going into third year

Should the above courses not run, or be replaced by new courses, then the guidelines stated above will be applied to replacement courses that relate to viticulture, horticulture or agriculture.

Applications close 31st of January.

# Centrelink Scholarships & Assistance

## Tertiary Access Payment (TAP)

The Tertiary Access Payment (TAP) is a one off payment of up to \$5,000. It's to help eligible students with the cost of moving to study. To get the payment you need to meet some rules.

These include:

- moving from a regional or remote area for tertiary study that's at least 90 minutes away from your family home location by public transport. You can check if your family home is in a regional or remote area using the [Student Regional Area Search](#).
- starting tertiary study in the year after finishing year 12 or equivalent.
- an Australian resident
- studying a tertiary course at certificate IV or above in the 12 months immediately after completing year 12
- 22 or younger on the day you start your tertiary course
- study at least 75% of a full-time study load
- study a course with a minimum duration of one academic year.
- meet the delivery method of your study program e.g. face-to-face, multi-modal and at a Regional University Study Hub (including as an online student).
- have parents or guardians whose income is under the current combined parental income limit of \$250,000.

You can claim this payment in your first year of tertiary study only.

## Relocation Scholarship

You might get a Relocation Scholarship if you're a student getting Youth Allowance or ABSTUDY and you meet these rules:

- are a dependent student or an independent student for a special reason
- study in a specific place
- meet the study rules
- get at least \$1 of Youth Allowance as a student or ABSTUDY Living Allowance.

## Student Start-up Loan

The Student Start-up Loan is a voluntary \$1,273 loan for eligible students who get Youth Allowance, Austudy or ABSTUDY Living Allowance. You can get the loan up to 2 times a year, once each loan period. Loans are tax free and you don't need to declare them to us as income for your regular student payment.

**You have to pay back the loan once you start earning a certain amount of income. You should think about how this will impact you in the long term before you apply**

# Health, Nursing and Medicine

## Rural Pharmacy Scholarship

The Rural Pharmacy Scholarship Scheme provides support to those students living in remote and rural areas. The scholarship gives the opportunity for students to complete undergraduate or postgraduate studies and are then encouraged to seek employment in rural and remote areas following graduation.

### Eligibility:

- You must be an Australian citizen.
- You need to be enrolled or accepted for enrolment in an Australian university as a full-time student and be studying an undergraduate or graduate degree that leads to a registrable qualification as a Pharmacist.
- You have lived in a rural or remote area for at least five consecutive years or eight years total since the age of five.
- You need to be a member of (or be intending to join) your university's student Rural Health Club and be able to prove evidence of enrolment.

## Australian Rotary Health Scholarships

Australian Rotary Health provides scholarships for Rural Nursing, Rural Medicine, and Indigenous Health.

Indigenous Health Scholarship - These yearly scholarships are awarded to Indigenous tertiary students as a way to support the barriers of tertiary study and qualification in Australian Indigenous populations. Each scholarship is worth \$5,000 per year.

Rural Medical Scholarships - ARH uses its rural medical scholarship program to create incentive for students to undertake at least one year of work placement in rural Australian communities. Each annual scholarship is worth \$5,000.

Rural Nursing Scholarships - ARH uses its rural nursing scholarship programs to create incentive for students to undertake their final year of clinical placement in rural Australian communities. Each annual scholarship is worth \$12,500.

The Undergraduate (entry-to-practice) Nursing and Midwifery Scholarships Program aims to train and upskill the next generation of registered nurses and midwives through scholarships which aim to reduce financial disincentives associated with undertaking an undergraduate (entry-to-practice) nursing or midwifery degree, including the costs of clinical placements.

\* Scholarship applications for Round 3 (2023 and 2024 intake) will be open from 24 July 2024 to 11 September 2024.

Eligibility:

- Study must be by course work or research and must be at an Australian university or other accredited higher education institution.
- Must be able to demonstrate satisfactory academic progress.
- Must acknowledge the ANMC when presenting at conferences, or in media reports and publications related to study or research

## **Royal Flying Doctors Service - Give Them Wings Scholarships**

RFDS Victoria offers rural students support through the Give Them Wings scholarship program. To be eligible, students must be:

- An Australian citizen or permanent resident
- Studying full time at a Victorian university campus
- Currently residing in, or have grown up in, regional, rural or remote Victoria

To be eligible, you must be enrolled full-time in an accredited Australian Tertiary Education Institution and be studying for a certificate, diploma, degree or traineeship in any of the following areas:

<b>Medicine</b>	Including medical and health sciences, surgery and medical research.
<b>Healthcare</b>	Including health and fitness-related specialties, sport sciences, health services assistance and international health.
<b>Specialist Healthcare</b>	Including nursing, optometry, dentistry and pharmacy.

# Education

## Department of Education & Training – Early Childhood

Early Childhood Scholarships are available to help people build their careers in early childhood education, without an additional financial burden. The Early Childhood Scholarships and the Early Childhood Aboriginal pathway scholarship initiatives are part of the Victorian Government's investment to bolster our kindergarten workforce. Scholarships can be used to pay for course fees, living costs while you study, or other costs associated with your education.

Early Childhood Scholarships Program offers (before tax):

- \$25,000 towards an approved undergraduate qualification
- \$12,000 towards an approved graduate diploma qualification
- \$18,000 towards an approved master's qualification.

Early Childhood Aboriginal Pathway Scholarship offers:

- \$34,000 towards an approved undergraduate qualification
- \$16,000 towards an approved graduate diploma qualification
- \$24,000 towards an approved masters qualification

## Department of Education & Training – Secondary Teaching

If you enrol in a Victorian secondary school teaching degree for the first time in 2024 or 2025, you could be eligible for a scholarship that pays you while you learn and can cover costs of your studies.

- A Victorian or designated border community resident domestic student. For the purposes of STS, this is defined as:
  - an Australian citizen, or
  - an Australian permanent resident, or
  - a New Zealand citizen living in Victoria, or
  - an Australian permanent humanitarian visa holder
- someone whose place of primary residence is in Victoria or a designated border community during completion of their eligible initial teacher education (ITE) degree (see below for a list of designated border communities).
- enrolled in a secondary or dual qualification (primary-secondary) school initial teacher education degree accredited by the VIT, or accredited by an equivalent regulatory State or Territory authority and recognised by the VIT, with a first census date between 1 January 2024 and 31 December 2025.
- have commenced their eligible program at the time of application.

- undertaking the eligible degree at a minimum of 50% study load (equivalent full-time study load – EFTSL) at the time of assessment.

Note: Victorian residents who are enrolled in a secondary or primary-secondary school ITE program at a non-Victorian ITE provider, and meet all other eligibility criteria, may apply for STS. Eligibility will be determined on a case-by-case basis by the Department of Education.

Eligibility includes enrollees in both undergraduate and postgraduate Victorian secondary ITE programs.

## **Commonwealth Teaching Scholarships**

Commonwealth Teaching Scholarships support new undergraduate and postgraduate teaching students to meet the costs of their study in exchange for teaching in government schools or government-run early learning settings for a period of time after graduating from their degree.

Scholarships of up to \$40,000 per student are available for full-time undergraduate initial teacher education (ITE) students (\$10,000 per year for a four-year qualification) and up to \$20,000 for full-time postgraduate ITE students (\$10,000 per year for a two-year- qualification).

Applications are strongly encouraged from school leavers and career changers who meet the eligibility criteria and who are high-achieving students (with an ATAR of 80 or above or equivalent academic result), First Nations peoples, people for whom English is an additional language or dialect, people with disability, people from regional, rural or remote locations, mid-career professionals or people from low socio-economic backgrounds, who aspire to a rewarding career in teaching.

### Eligibility:

- and individual located in Australia
- an Australian Citizen
- a permanent resident
- a holder of a humanitarian visa
- a New Zealand citizen living in Australia
- intend to enrol, or be enrolled, for full-time study in an accredited ITE program commencing in the first study period or semester of 2024
- not have commenced an accredited ITE program prior to the year the scholarship will be offered.
- be willing to commit to teaching for four years (undergraduate) or two years (postgraduate) in government schools or government-run early learning settings.

Scholarships will be available over five rounds from 2024 to 2028 with up to 1,000 scholarships per year to be offered. Please note, the 2024 scholarship application process has now closed. Applications for 2025 will open later 2024/early 2025.

The Young Farmers Upskill and Invest Scholarship offers up to \$10,000 per scholarship, including:

- up to \$5,000 towards study
- up to \$5,000 to invest in putting new skills into practice, with professional development, business planning or other on-farm activities.

The scholarship program is designed to be flexible and to fit with the demands and ambitions of young farmers and farm workers.

### Eligibility

- Be aged 35 years or under at the time of the application close date
- Be working in a food and fibre farm business in Victoria at least three days per week for the past three months
- Have at least two years of total experience on-farm
- Be an Australian citizen or permanent resident currently residing in Victoria.

## Gardiner Dairy Foundation Scholarships

The Gardiner Foundation offers tertiary scholarships to up to seven individuals residing in Victorian dairy communities. Students must be commencing studies in 2024 to pursue a career that will either directly benefit the dairy industry and/or benefit dairy communities. Each scholarship is worth \$10,000 per year and is available for the first three years of a scholar's University or TAFE course.



# Building and Construction

## Building and Construction Foundation Scholarships

The Foundation provides financial assistance to individuals through three scholarships. Applications are received on a rolling basis (no deadlines) for the (1) Early Career; (2) Career Advancement; and (3) Leadership scholarships.

### Early Career Scholarship - \$2,200

This scholarship is best for those new to the industry. It is available to you if you would like to undertake a pre-apprenticeship, apprenticeship or other construction-related training. The funds are split into two:

- \$1,200 towards approved course fees, plus
- \$1,000 towards quality tools relevant to your trade

Previous successful applicants have used these funds towards an array of qualifications including Certificate II in Electrotechnology, Certificate III in Carpentry and Level 1 and 2 AutoCAD training.

The \$1,000 annual scholarship will be awarded to a law student or lawyer who has a strong academic record and a commitment to the practice of animal law through active and substantial engagement with animal law and animal protection organisations and initiatives.

- If an applicant has received a Long Tan Bursary, they cannot be considered for another Long Tan Bursary.
- In receipt of, or eligible to receive, a means-tested Commonwealth educational benefit - Youth Allowance, ABSTUDY, Austudy or Veterans' Children Education Scheme (VCES).
- Be a child or a grandchild of an ex-serving veteran.
- The veteran must be an Australian ex-serving veteran with operational service including eligible war service, war-like service and peacekeeping/peacemaking service OR 3 or more continuous years of full-time other service, as a member of the Australian Navy, Army or Air Force.

- The young person must have a clear need for financial assistance and be studying in Australia for the two year period of the program.

## **The Francis Gregory Foundation**

The Francis Gregory Foundation was established in 2012 to provide financial support to children of primary producers to assist them to undertake university undergraduate education by reducing financial barriers.

The Foundation will provide two scholarships of \$6,000 per annum (for the duration of the undergraduate degree) to students whose main family income is derived from primary production.

In order to be considered for a scholarship, a student must:

- Be an Australian citizen
- Be a registered VCE student and achieve a minimum ATAR score of 80
- Be a resident of Victoria in an FZ zone (as defined by Victorian Government Department of Planning and Community Development) and reside on the land producing the family income
- Be the child of parents who own and/or operate the property from which the main family income is derived. (Please note that dependents of farm employees are not eligible for this scholarship.)
- Have demonstrated financial hardship in relation to pursuing university study
